Please be advised that proof of the following information is required in order to qualify for a 2-1/2% rental increase only.

- At least one-year residency in your present household
- Total income, including the incomes of all other persons living in the household, and whether taxable or nontaxable, must not exceed the average per capita income for Bergen County Residents (see Income Figures sheet).
- Must be at least 62 years of age or at least 55 years of age and the surviving spouse of a formerly qualified "Senior Citizen Tenant"
