MINUTES April 26, 2022

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on April 26, 2022 at 7:00 p.m. in Council Chambers at 320 Boulevard.

Mayor DeLorenzo declared the meeting in Session and Borough Clerk Laurie Varga stated that the meeting complied with the Sunshine Law, Adequate notice of this meeting has been made to all members of the Council on January 3, 2022 and transmitted to The Record and The Herald News on January 5, 2022 in accordance with the provisions of the "Open Public Meetings Act", Chapter 231, P.L. 1975.

SALUTE TO THE FLAG AND PLEDGE OF ALLEGIANCE: Mayor DeLorenzo led in the Salute to the Flag and Pledge of Allegiance.

Mayor DeLorenzo expressed his condolences on behalf of the Mayor & Council to Foreman of DPW, Angelo Roccamo, who lost his father.

INVOCATION: The Invocation was given by Councilman Kistner

MINUTES: April 12, 2022Executive Meeting

April 27, 2021 Regular Meeting

Mayor DeLorenzo asked the Clerk to read the list of minutes for approval. When done, he asked for a motion to approve the minutes which was made by Councilwoman Ciocia, seconded by Councilman Sickels and carried with Councilman Bing and Councilman Meli abstaining from the second because they were not on the Council at that time.

Mayor DeLorenzo asked the clerk to read the list of communications. When done he asked if anyone would like to have the communications read. Seeing no one he asked for a motion to approve the Communications, which was made by Councilman Sickels, seconded by Councilman Kistner and unanimously carried.

BILLS:

Mayor DeLorenzo asked the Clerk to read the Bills resolution. When done, he requested a motion to approve the resolution which was made by Councilwoman Ciocia, seconded by Councilman Bing, and carried with Councilman Hillman voting no.

WHEREAS, claims and accounts amounting to \$2,329,973.33 specified in the schedule hereto annexed, have been examined and approved by the Finance Commissioner, or his Deputy; and

WHEREAS, the Chief Financial Officer has certified that funds are available in the accounts listed for payment of the claims;

NOW, THEREFORE BE IT RESOLVED, that the claims be paid and checks be issued on the funds and accounts indicated on the attached schedule.

REPORTS:

Fire Department:

The Fire Department held their monthly meeting last Thursday. They have been very busy not only in town but mutual aid as well. Assistant Chief Greco stepped up in the Chief's absence, as did, Gumbrecht, Hernandez and Taylor. Everyone is doing a great job. The veteran's and young guys are all stepping up.

DPW:

On Good Friday there was garbage left on the Boulevard. The DPW cleaned it up immediately.

Finance:

The current fund cash balance at March 31st is \$4,413,652. The entire balance is earning .10%. Cash disbursements for the month of March totaled \$4,384,178 of which \$2,603,857 was for local school taxes (59%), \$896,144 was for salaries (20%), and \$884,177 was for other expenses (21%).

2022 Budget hearing 5/10/22

- CFO funded Borough LOSAP contributions to be made to Borough Fire & EMS volunteers.
- Homestead Rebates were mailed to eligible taxpayers.
- Walter Avenue parking lot has been seal coated and lined. Signs have been ordered and lot should be open soon.
- Cash balances will increase as 2nd quarter tax bills are due 5/10/22

LAND USE BOARD:

Permit totals from March were \$16,493.00. Many new residential and commercial applications are being received, as well as permits for outdoor work.

The Land Use Board held a meeting April 6, 2022. A resolution was memorialized for approval of the Bulk Variances at 324 Bell Avenue. The application for Variances at 163-167 Kipp Avenue was withdrawn.

In response to Hurricane Ida, The Building Department continues to work with homeowners. Fees for permits relating to damage the storm caused have been waived.

In Property Maintenance, homeowners have been notified concerning the trash pickup schedule as well as spring outdoor property maintenance protocol.

RECREATION:

The Recreation committee meets regularly and they are continuing to plan for the reopening of the Youth Center. Summer Camp registration is open and day trips are being resumed. Travel softball registration will begin next week.

TRANSPORTATION:

The Senior Bus is currently used to provide transportation for our Senior Citizens, (age 62 and older) living in Hasbrouck Heights.

The bus travels to Shop-Rite on Wednesday and Stop N Shop on Friday of each week. During the weeks of 3/21/22 through 4/22/22 there was an average of 9 Senior Bus riders per week to Shop Rite and 6 per week to Stop and Shop.

The bus traveled to Paramus Park on Tuesday, April 12 with 9 riders and Walmart on Tuesday, April 19, 2022 with 7 riders.

LIBRARY:

As of March, 2022 the total card holders were 7.314.

HEALTH DEPARTMENT:

During the month of March, the Health Inspector conducted 28 food inspections, 11 grease trap inspections and 4 complaints of various natures.

The Dept. of Vital Statistics issued 166 certified transcripts, recorded 8 resident deaths and six marriage licenses.

SOCIAL SERVICES:

There were a total of 87 visitors to the Food Pantry from 3/28/22 through 4/25/22; an average of 17 patrons per week.

We would like to thank our Food Pantry Volunteers for organizing and stocking shelves, as well as packing bags and distributing the food on Monday mornings. We appreciate all their help.

Thank you to the residents and various organizations who continue to donate food and gift cards. Hasbrouck Heights is a strong community and it is comforting to know that we can count on our fellow residents for support during these uncertain times.

Donations to the food pantry are always needed. Items in need are pasta, cereal, mac & cheese, canned goods, snack items, toiletries, cup o soup and paper goods. Paper and plastic bags are also needed so we can redistribute the food.

Donations are accepted at the Borough Clerk's Office, Monday through Friday between the hours of 9am and 4:30pm.

MAYOR'S REPORT:

Mayor DeLorenzo is very happy that Hasbrouck Heights is the 3rd safest city in New Jersey. We are lucky that we have dedicated people here and the Police Department is an important factor but it also has to do with our community as a whole. We are making progress on the Walter Avenue parking lot. Our new IT Specialist, Vincent Gareffa has installed all the software and windows updates at Town Hall, Fire Dept. and DPW. We also have a new contract for a security program to protect us from Malware Bytes. We went from 17 Licenses to 27 and identified computers that were not protected properly. We have a new Cyber company we are going to be dealing with and will upgrade our protection. We got a \$40,000 quote down to \$4,000. We have software and other desktop computers we are working on. We plan on having a technology committee meeting in the next week or so. Our new tech will be at the May work session to update us.
